2. REGISTERED OFFICE: The Registered Office of the Society shall remain in the Union Territory of Delhi and at present it is at the following address:-

POLE NO. 1, VILL. TILANGPUR KOTLA, NEAR TRANSFORMER, MAIN NANGLOI TO NAJAFGARH ROAD, NEW DELHI-43.

AIMS & OBJECTS:

1. To provide all sorts of help to promote and train needy persons of the society.
2. To organise cultural programme, Seminars, debates and other functions to promote science literature and fine Arts.
3. To organise free eye-camps and other camps for treatment of poor persons of the society.
4. To start, manage control and run free dispensaries in aid the free treatment of needy persons.
5. To organises charity shows etc for promotion of science, art, literature etc.
6. To organise programme for eradication of illiteracy among the society.
7. To promote all National Programme of the state for promotion of the weaker section or ailing peoples or poor needy persons.
8. To do all other social activities and welfare activities in the interest of the poor, economically or social weaker section or needy people of the society.
9. To start, manage, control and run poly-technic institution for men or women or for both.
10. To provide educational and support to all poor, needy persons and their dependents.

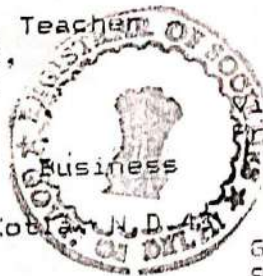

No member of the society shall have any personal claim or any moveable or immovable properties of the society or make any profits, whatsoever, by virtue of this membership.

RULES AND REGULATIONS OF :-

1. NAME The name of the Society/Association shall be SEHRAWAT
PEOPLE EDUCATIONAL AND WELFARE SOCIETY.

2. MEMBERSHIP Subject to the approval of governing body any person may become a member of the association provided he/she believes in the aims and objects of the Society/Association

3. SUBSCRIPTION The rate of subscription for all the members shall be Rs.2/-p.m.

4. REFUSAL The governing body of the association may refuse any person for the membership provided reasons for refusal is communicated to the person concerned.

5. EXPULSION The Governing body of the association may expel any member from the society, on the the following grounds:-

- (i) If the members works against the aims and object of the association.
- (ii) If the member fails to pay the timely subscription continuously for four months from the due date of paying the subscription.
- (iii) If the member tenders his/her resignation.
- (iv) If the member fails to attend four meeting of General body and governing body.

The reasons of expulsion shall be communicated to every member. Every such expelled member shall have a right to appeal before the general body which may or may not be accepted.

6. GENERAL BODY There shall be a general body of the Society consisting of all the member. The meeting of the general body shall be held after every on year with 1/3 querum shall be required in the adjourned meetings.

1. To prepare annual programmes in the School.
2. To pass annual budget of the association in the name of SEHRAWAT PEOPLE EDUCATIONAL AND WELFARE SOCIETY.
3. To discuss and to decide all such other matters and issues which are directly or indirectly related to the affairs of the association.
4. To appoint an auditor he will annually inspect the accounts of the society/association Funds.
5. To appoint necessary staff and to determine their service conditions.

7. GOVERNING BODY :- There shall be a governing body of the association to look after and manage the day to day affairs of the association shall consist of minimum 7 and maximum 11 members.

shall keep all types of record of the association fund including the register of members containing there in the names, addresses and other brief particulars.

c) TREASURER

He shall collect subscriptions. Charges from the members and he shall also be responsible for keeping and maintenance of a true and correct accounts of the society's association funds.

9. FINANCIAL YEAR: The financial year of the association shall be 1st April to 31st March every Year.

10. SOURCE OF INCOME: Subscription, charges from the members shall be the source of income of the society/association.

11. BANK ACCOUNT OPERATION: The funds of the SEHRAWAT PEOPLE EDUCATIONAL AND WELFARE SOCIETY. will be kept in a State Bank of India.

12. ELECTION: The governing body of the society shall be elected for a term of two years in the general body meeting. The secret ballot system shall be the mode of election.

13. ANNUAL LIST: Every year a list of governing body office bearers and members shall be filed in the office of Registrar of Societies/association. Delhi as required u/s 4 of S.R. Act of 1860.

14. LEGAL PROCEEDING: The society/association may sue or be sued in the name of its president as required u/s 6 of S.R. Act of 1860.

15. AMENDMENT: Any amendment in the memorandum or rules of this society shall be carried out in accordance with procedure laid down u/s 12 and 13 of S.R. Act of 1860.

16. DISSOLUTION: This assoc. may be dissolved in accordance with procedure laid down u/s 13 and 14 of S.R. Act of 1860.

All the provisions of S.R. Act of 1860 Act of 1957. as extended to Union Territory of Delhi shall apply to this Association/society.
